- 4) We shall also put on the College Website the constitution of various Committees/Cells as mandated in the various UGC Regulations notified from time to time. We shall conduct the meetings of the statutory bodies regularly and upload the minutes of the meetings on the college website.
- 5) We shall also upload such information on such web portals as may be specified by the Commission from time to time

Apart from the above requirements, we shall also ensure the following-

- 1) We shall Establish and compose the Internal Complaints Committee (ICC) as per the UGC. Regulation, 2015
- 2) We shall Comply with the UGC (Redress of Grievances of Students) Regulations, 2015, and Compose the 2 SGRC as per these Regulations
